Christian County is requesting a variance to the OTO Major Thoroughfare Plan for a street along Southernview.

The public is invited to comment on a variance request for the Major Thoroughfare Plan (MTP). The MTP is part of *Transportation Plan 2040* and outlines functional classifications of roadways with design standards to achieve those functional classifications. Southernview is classified as a Collector, which requires 660 feet for full access intersection spacing. To optimize ingress and egress for a new development, Christian County is asking to create a full access intersection 250 feet east of NN along Southernview.
