The Ozarks Transportation Organization announces a public comment period for the public to review and comment on the Annual Listing of Obligated Projects (ALOP). The ALOP is a listing of federal funds obligated on projects within the OTO area from July 1, 2023 to June 30, 2024. Though published separately, the ALOP is part of the FY 2025-2028 Transportation Improvement Program.

The OTO Board of Directors will review and consider accepting the Annual Listing of Obligated Projects at their September 19, 2024 Board Meeting, held at 12:00 noon. After reviewing recommendations and entertaining public comment, the OTO Board of Directors will decide whether to formally accept the Listing.
